Chairman Junker called the meeting to order at 5:12pm.

Chad Fuller made the motion, seconded by Barbara Owens, to adopt the agenda as presented. The motion carried 7-0.

Chairman Junker called for a motion to go into closed session to preserve the attorney client privilege pursuant to the North Carolina General Statues listed on the agenda, to review personnel and property matters protected by State Law and to discuss student concerns made confidential by General Statutes and the Family Educational Rights and Privacy Act. Dub Potts made the motion, seconded by Paul Drechsler; the motion carried 7-0. The Board went into closed session at 5:15pm.

Chairman Junker reconvened the meeting at 6:00pm and offered the invocation. Girl Scouts Troop 2580 led the Pledge of Allegiance.

Barbara Owens made the motion, seconded by Terry Hales, to approve the minutes of the November 13, 2018 regular Board of Education meeting as presented. The motion carried 7-0.

### Reorganization of the Board

Chairman Junker and members of the Board thanked Barbara Owens and Chad Fuller for their decade of service to Davie County Schools and the Davie County Board of Education. The Board expressed their appreciation of the hard work, leadership, dedication, and hard fought accomplishments of Mrs. Owens and Mr. Fuller. The Board also thanked Dr. Hartness for his example of leadership and his vision for Davie County Schools. The superintendent was described as a friend, a gentleman, a champion for important causes, and a problem solver. The Board made sure that Dr. Hartness knew how much he is respected and appreciated by the community and school system. Mr. Fuller and Mrs. Owens were presented plaques for their service and then they exited the meeting.

Newly elected Board members, Lori Smith and David Carroll, as well as Chairman Junker, were sworn into office by Davie County Clerk of Court Ellen Drechsler and then proceeded to take seats at the table.

Board Attorney Jill Wilson opened the floor for nominations for Board Chairman. Paul Drechsler nominated Mr. Clint Junker to remain Chairman of the Davie County Board of Education for 2019. Dub Potts seconded the motion. The nomination was confirmed with a 6-0-1 vote, with Mr. Junker abstaining. Dub Potts nominated Mrs. Wendy Horne to remain in the position of Vice-Chair; Paul Drechsler seconded the motion. Mrs. Horne received a 6-0-1 vote and was confirmed as the Vice-Chair.

### **Board Report**

Chairman Junker reviewed upcoming events in December. He announced the next scheduled meeting of the Board of Education will be Tuesday, January 8, 2019 at 6:00pm.

### Superintendent's Report

Dr. Hartness began his monthly report by congratulating Clint Junker, Lori Smith, and David Carroll and reminded the Board of the important work they do and advised the Board to always keep the focus on what is best for students.

Dr. Hartness stated that is was an honor and a privilege to serve Davie County Schools for the last seven and a half years. Dr. Hartness reflected on the great history of Davie County Schools and noted how the community has continued to grow strong as it has overcome obstacles and kept the focus of Davie County on the things that really matter. The Superintendent thanked the students of DCS for inspiring him; the Board for their commitment to public education, the district's principals, teachers, and staff for their continued hard work; the Executive Leadership Team for their honest feedback, trust, and respect; the community for their support; and his mentors for their wise counsel. Dr. Hartness then thanked his family, Lisa, Madison, and Molly for their unconditional love and support as he was able to do the work he was called to do.

### Recognitions

Jeff Wallace and Mike Absher recognized Coach Bob Donley for his accomplishment of being named the 2018 Central Piedmont Conference Golf Coach of the Year. Coach Donley has grown the women's golf team and had several golfers qualify for the state tournament at Pinehurst.

Jeff Wallace and Mike Absher also recognized the Davie County High School Women's Tennis Team. They were the 2018 Central Piedmont Conference Champions and 2018 CPC Conference Tournament Champions. Coach Absher also pointed out that this record setting team was also a four year scholar athlete team with a team GPA averaging at or above a 3.1.

Jeff Wallace and Mike Absher then recognized an individual member of the women's tennis team, senior Laura Becker. Miss Becker was the Women's Tennis 2018 Midwest Regional Champion and the 2018 Central Piedmont Conference Player of the Year.

Superintendent Hartness recognized the 2018 Holiday Card Art Contest Winners. The Central Office Staff voted on one entry from each grade level school winner: elementary, middle, and high school. Congratulations were given to the school level winners: Noelle Walker, CES; Dashel DesNoyers, CZES; Ethan Diemer, MES; Eli Chamberlain, PES; Ryann Goodwin, SGES; Camryn Bullard, WRD; Emma Denney, CDA; Isabelle Bracken, NDMS; Mia Carrillo Chico, SDMS; Abby Wilson, WEMS; Litzy Acevedo-Gama, DCECHS; Ashton Cox, DCHS. The three winners, Camryn Bullard, Isabelle Bracken, and Litzy Acevedo-Gama each received a Walmart gift card.

### Consent Agenda

Wendy Horne made the motion, seconded by Terry Hales, to approve the consent items as presented. The motion carried 6-0-1 with Mr. Carroll abstaining. Consent items approved: Budget Amendments, Donations Report, and Personnel Recommendations.

### **Public Address to the Board**

None.

### **Business items**

Dr. Hartness explained that at the November 13, 2018 Board meeting, he presented revisions to policies for the Board to review. The Superintendent explained the updates are based on the recommendation of the NCSBA. Dr. Hartness then presented the policies for approval. Terry Hales made a motion to adopt the policies as presented; Paul Drechsler provided the second. The motion passed 5-0-2 with new board members abstaining.

Dr. Hartness explained to the Board the finance department had acquired the services of McNeary Consulting Services to conduct a review of the district's property and casualty insurance policies that are scheduled to renew in January 2019. In October 2018, McNeary released insurance specifications to bidders. Proposals were received and reviewed by McNeary in November 2018. McNeary has provided a summary of the proposals and a recommendation that would result in significant savings and broader insurance coverage. Dr. Hartness asked the Board to review McNeary's recommendation and make a decision on insurance coverage to begin in January 2019. The Superintendent mentioned the great relationship Davie County Schools has had with Cincinnati Insurance and Johnson Insurance and let the Board know he had already spoken with Mr. Johnson. Terry Hales made the motion to accept the recommendation by McNeary Consulting Services; Paul Drechsler seconded the motion. The motion passed 6-0-1 with Mr. Carroll abstaining.

Jeff Wallace presented two options for the 2019-2020 traditional school calendar. Mr. Wallace explained the calendar committee met on November 7<sup>th</sup> and November 28<sup>th</sup> to draft these two options and that school representatives and parents from our different schools participated in developing the calendars. Davie County Schools' staff will have the opportunity to vote on a calendar; the top choice will be presented to the Board in January 2019 for consideration. Board members discussed the possible placement for Spring Break and determining the start date for the school year.

### **Committee and Staff Reports**

Assistant Superintendent Jinda Haynes and CTE Director Anthony Davis presented an update on the progress made possible since a Golden LEAF Grant was awarded to Davie County Schools in 2017. Mrs. Haynes explained the significant positive impact this grant has made in increasing opportunities for students and staff in the CTE and STEM departments at Davie County High School including: improved innovated spaces, lab enhancements, professional development for staff, and soft skill development for students. Mrs. Haynes described the impact the Golden LEAF Grant was making already with 48% of 2018 Davie High School seniors graduating as CTE concentrators. The number of students earning credentials and the number of students participating in internships and work based learning has increased as well.

### Adjourn

Dub Potts made the motion to adjourn with a second from Wendy Horne; the motion was approved with a 7-0 vote. The meeting adjourned at 7:20pm.

Dear Dr. Hartness:

On October 9, 2018, Davie County Schools accepted McNeary's proposal to handle a competitive bid project for the January 1, 2019 property and casualty insurance coverages.

On October 19, 2018, McNeary assigned markets and released insurance specifications to the following bidders:

- Johnson Insurance Agency (incumbent agent)
- Surry Insurance Agency
- North Carolina School Boards Association
- Department of Public Instruction (DPI)

Proposals were received on November 16, 2018 from Johnson Insurance Agency, Surry Insurance Agency and DPI. The North Carolina School Boards Association was unable to provide a proposal since their program operates on a July 1 through June 30 fund year.

The proposal from DPI included coverage quotes for property and equipment breakdown only. Since the proposals from Johnson Insurance and Surry Insurance were all inclusive, McNeary could not recommend DPI's proposal for consideration.

Johnson Insurance Agency, Davie's incumbent agent, provided a proposal for all lines of coverages requested in the specifications through Cincinnati Insurance Company, the incumbent insurance carrier. They also provided a proposal through American Alternative for all lines of coverages requested. As shown in the Premium Summary chart, Cincinnati's total premium is \$14,165 higher than expiring with comparable limits, deductibles and terms/conditions as expiring. American Alternative's total premium is \$41,184 higher than expiring with comparable limits, deductibles and terms/conditions as expiring.
