MINUTES DAVIE COUNTY BOARD OF EDUCATION TUESDAY, OCTOBER 1, 2019

The Davie County Board of Education met at 6:00pm, October 1, 2019, in the Board Room of the Central Davie Education Center, 220 Martin Luther King Jr. Road, Mocksville, NC.

Chairman Junker called the meeting to order at 5:15pm.

Wendy Horne made the motion, seconded by Terry Hales, to adopt the agenda as presented. The motion carried 7-0.

Chairman Junker called for a motion to go into closed session to preserve the attorney client privilege pursuant to the North Carolina General Statutes listed on the agenda, to review matters protected by State Law, and to discuss student concerns made confidential by General Statutes and the Family Educational Rights and Privacy Act. Paul Drechsler made the motion, seconded by Dub Potts; the motion carried 7-0. The Board went into closed session at 5:18pm.

Chairman Junker reconvened the meeting at 6:00pm and offered the invocation. Chairman Junker led the Pledge of Allegiance.

David Carroll made the motion, seconded by Lori Smith, to approve the minutes of the September 10, 2019 regular Board of Education meeting as presented. The motion carried 7-0.

Board Report

Chairman Junker welcomed Paul Drechsler back after having surgery in August 2019. Mr. Junker reviewed upcoming events stating Manufacturing Day at the middle schools are Friday October 4, 2019. The NCSBA Fall Law Conference is October 16 – 18, 2019 in Asheville, NC. The Board of Education lunch at South Davie Middle will be at 11:30am on Thursday October 24, 2019. The next Board of Education meeting will be Tuesday November 5, 2019 at 6:00pm.

Superintendent's Report

Mr. Wallace began his monthly report with a moment of silence in memory of Coleen Gaither; Mrs. Gaither passed away driving a bus on September 19, 2019. She had been with Davie County Schools since 1977.

From this rare situation on the bus, Mr. Wallace recognized the students who came to Mrs. Gaither's aid when they noticed she became unresponsive and the bus was veering into the left lane. LaShawna Adkins, Elizabeth Jones, and Joseph Fox all helped to get the bus stopped safely and worked with Emergency Services Personnel to effectively get control of the situation. Mr. Doyle Nicholson presented these three students with certificates of appreciation. Andy Drye and Joseph Ashburn, with EMS, also came to honor the three students. Mr. Ashburn stated how proud he was of their calmness and quick thinking during such a tragic event. He told the students if any of them wish to pursue a career in EMS, they would sponsor them; paying the tuition, fees for books, etc. Mr. Nicholson also commended the EMS personnel stating they had the kids off the bus, organized, and already had their names written down for the school staff once they arrived at the scene of the accident.

Mr. Wallace stated that he along with Dub Potts, Terry Hales, and David Carroll attended the NCSBA District 5 Meeting at Thomasville High School on Wednesday September 18, 2019. Mr. Potts currently serves as a board member for NCSBA.

Mr. Wallace gave an update on Ignite Davie. This is the college promise program through Davie Community Foundation and DCCC. They are seeking 3 million dollars to kick start this program. Over 1 million dollars have already been committed. This program would allow Davie County students to attend DCCC tuition free. Touchdowns for Education occurred on Friday September 27, 2019 at the Davie County High School varsity football game. That night \$18,000 was raised by donors based on the amount of touchdowns Davie scored. The final score was AL Brown 43, Davie 40.

Lastly, Mr. Wallace welcomed back Paul Drechsler after his surgery.

Recognitions

Mrs. Jennifer Lynde asked Mr. McCrary, South Davie Middle School Band Director, to recognize Hazel Marion for being selected into the North Carolina All-State Band. Hazel was in 8th grade for this honor and she was 2nd chair-flute. Jennifer Lynde also recognized Quinn Collins, a recent graduate of Davie County High School who is now in the U.S. Marines. Quinn was selected into the North Carolina All-State Band while in 12th grade for being 5th chair –trombone.

Mr. Jeff Wallace asked Mrs. Brittany Holland, Assistant Principal at Cornatzer, to come and speak about her events she attended after she was recognized as the 2018-2019 NC National Outstanding Assistant Principal of the Year. At the National Association of Elementary School Principals National Principals Conference in Spokane, WA, Mrs. Holland was named 1 of 6 assistant principals recognized as National Assistant Principals of the year. Mrs. Holland was also named the North Carolina Ambassador for the World Education Forum.

Mrs. Jinda Haynes introduced Melinda Beauchamp, United Way of Davic County, Inc Chief Executive Officer, to recognize the school location with the highest percentage increase of donations to United Way from last year. Central Davie Education Center won that honor. Mrs. Beauchamp stated Davie County Schools raised \$29,785.42 for the United Way campaign this year. In addition, each employee who made a pledge of at least a \$52 'Building Block' was entered into a drawing for tickets to the November 17, 2019 Panthers vs Falcons NFL game, courtesy of the Pierce Group Benefits. Mrs. Cindy Cline from North Davie Middle School won the tickets.

Consent Agenda

Mrs. Jinda Haynes interrupted Mr. Junker saying she had an addendum to the Personnel Report. She then passed paper copies of the addendum to the board members. Terry Hales made the motion, seconded by Lori Smith, to approve the consent items as presented. The motion carried 7-0. Consent items approved: Parent Advisory Council-Additions to Mocksville Elementary School and Cornatzer Elementary School, Donations Report, Personnel Recommendations, and a Personnel Recommendation addendum.

Mrs. Haynes introduced Mrs. Raymonda Shelton as the new Principal at Cornatzer Elementary School. She is currently the Assistant Principal at William R Davie Elementary School. Mrs. Shelton's start date will be October 14, 2019.

Business Items

Mr. Anthony Davis presented for the board to approve an increase in admission fees for Davie County High School JV and Varsity football and JV and Varsity basketball games to \$7.00 per person to offset rising costs for officials, uniforms, sports balls, etc. In September 2019, Winston Salem Forsyth County Schools passed a motion for the Central Piedmont 4A Conference schools to increase admission prices to JV/Varsity football and basketball games. Mr. Davis also asked the board to approve to start charging admission of \$6.00 per person for swimming and track meets. The last time the athletic department asked for an increase was August 12, 2014. Wendy Horne made the motion to approve admission changes as presented, Paul Drechsler seconded it. The motion carried 7-0.

Mr. Clay Harris presented the updated policy 6450 for the board's approval. This update will align policies 6450 and 6420 to the NCSBA's recommendation of \$90,000 for contract limits that will not need to go before the board if the amount has already been approved in the budget. Terry Hales made the motion to approve the updated policy 6450, Dub Potts seconded it. The motion carried 7-0.

Public Address to the Board

None.

Committee and Staff Reports

Mr. Anthony Davis presented a draft policy (Policy 3620) from the NCSBA about allowing homeschool children to participate in public high school level extra-curricular activities and athletics. The board, as well as the board attorney, had many questions regarding the dual enrollment, timeline of implementation, which clubs/sports to include, and other logistical issues that will need to be discussed. Many agreed that this will can be a great marketing venture to the homeschool children and families which in turn will hopefully improve their relationships with the school system. The policy will be voted on at our next board meeting.

Mr. Anthony Davis also presented the consideration for Early College High School students to participate in Davie County High School extra-curricular activities and athletics. No vote is necessary for this to pass. The administration will need to work closely with Mrs. Denise Absher, Principal at Davie County Early College High School, to meet and plan a policy laying out the requirements.

Mrs. Erin Foil presented on the accountability results for 2018-2019. She gave an overview of School Performance Grades, Proficiency (Grade Level Proficiency and College and Career Ready), Growth, SAT performance score, and the long term goals established in North Carolina. Mrs. Foil also shared that Mocksville Elementary School was in the top 5% of all NC Elementary schools for math growth. William Ellis Middle School was ranked 12th of all the NC schools for Overall Growth. DCS Workkeys scores ranked 6th of all NC districts.

Mrs. Jennifer Lynde presented on K-2 Math Assessment. At the end of the school year, Kindergarten, first, and second grade students are given the state's Math Summative Assessment. Each level saw an increase from 2018. Kindergarten had a 94% proficiency, First grade had an 88% proficiency, and Second grade had an 85% proficiency.

Mrs. Jennifer Lynde, Mrs. Peggy Nuckolls, Mrs. Stephanie Nelson, Mrs. Amy Spade, and Mrs. Renee Hennings-Gonzalez shared updates from Year 2 of the 5 year plan of DavieLEADS, sponsored by The Mebane Foundation. DavieLEADS' (Literacy Empowers All in Davie to Succeed) objectives include reaching children at an early age to foster appropriate development, providing support for preschool programs in creating more consistent curriculum and instruction to improve kindergarten readiness and increasing the percentage of students reading proficiently by the end of third grade as demonstrated on the NC End of Grade Reading Test and/or mCLASS reading assessment.

Adjourn

Lori Smith made the motion to adjourn with a second from Paul Drechsler; the motion was approved with a 7-0 vote. The meeting adjourned at 8:29pm.
